The new hotel at City of Dreams is expected to commence operation in 2018.

The intricately elegant tower that embodies Morpheus is the world's first free-form exoskeleton high rise. Morpheus will be situated in the iconoclastic mega sculpture designed by the late Dame Zaha Hadid, DBE. The new tower is one of the last and most brilliant designs created by the legendary architect. It presents the world's first free-form exoskeleton architectural composition incorporating a number of architectural and technological breakthroughs. Inspired by jade artefacts, no two pieces on the structure are the same. It comprises two towers with a total of 39 floors, connected at both the podium levels and the roof. A series of voids gives it sophistication and volume along with a distinctive appearance as well as exciting internal space. The epitome of contemporary luxury, Morpheus offers state-of-the-art amenities and courteous, world-class and attentive services to guests that satisfy the subconscious beyond the physical senses.

The unparalleled accommodations housing approximately 780 guest rooms along with suites, sky villas and duplex villas and the unique quality of luxury hotel services will be perfectly complemented by guest facilities exceeding 5-star hotel standards topped off by an infinity swimming pool some 130 meters above the ground. Among these will stand out three posh villas with an interior private pool presenting a truly exclusive experience for our VIP guests. Morpheus will also offer yet another choice to guests who already appreciate our gastronomic delights at City of Dreams with a dining experience at sky bridges presenting a panoramic view over Cotai. A good array of premium food and beverage outlets will serve a range of international cuisines. Twelve high speed observation lifts through the atrium with spectacular views of the interior architecture will whisk guests from one spot to another. In creating these facilities we will tap the greatest talent available to make sure Morpheus delivers the best of luxurious experience.
