**Melco Crown Entertainment's Flagship Property Leads Industry in  
Environmental Protection Efforts**

**City of Dreams is the first-in-Macau to get Indoor Environmental Quality  
Certification; all three hotels received 2010 Macao Green Hotel Award**

**MACAU, July 6, 2011** – Melco Crown Entertainment Limited (NASDAQ: MPEL) (“Melco Crown Entertainment” or “Company”), a developer and owner of casino gaming and entertainment resort facilities focused on the Macau market, and its properties’ efforts in environmental protection has been recognized by multiple awards in 2011, fortifying Melco Crown Entertainment’s leadership in using environmental-friendly facilities and equipments in its operations.

Melco Crown Entertainment’s flagship resort, City of Dreams, is the first integrated and entertainment resort in Macau to receive Indoor Environmental Quality (IEQ) Certification issued by SGS, a world-wide international certification company. The IEQ Certification of City of Dreams speaks for the level of comfort, hygienic and sanitary conditions and air quality in all its common areas, including gaming area, restaurants, hotels and shopping areas.

Meanwhile, all three hotels in City of Dreams including Crown Towers, Hard Rock Hotel and Grand Hyatt Macau have received the Bronze Award in the 2010 Macao Green Hotel Award. The award is organized by Macau Environmental Protection Bureau with the collaboration of Macao Government Tourist Office, and supported by several local trade associations. The award has been designed to leverage the importance of environmental management within the sector, and honor hotel establishments that have committed to environmental management.

“We are honored to be recognized both locally and internationally for the efforts we have put into making City of Dreams a truly green resort. We have always considered protecting the environment as one of our core values at Melco Crown Entertainment, and these recognitions are testament to our commitment in putting our core value into practice in our day-to-day operations,” said **Mr. Lawrence Ho, Co-Chairman and Chief Executive Officer, Melco Crown Entertainment.**
